Filming must not disturb the experience of the guests, prevent guests from accessing public areas, prevent guests from creating noise reasonable for a museum space, or require the Museum to make any accommodations outside of maintaining enough space for the filming crew and providing admission for the purpose of filming content.

4. Filming within regular hours (9:00 am - 5:00 pm on regular business days, 8:00 am - 7:00 pm during Cheyenne Frontier Days™) will not incur additional charges. Filming outside of these hours will incur a \$100 fee per hour to compensate our staff for overtime. Fees a

5. Any filming sessions that exceed one hour inside the Museum's galleries will incur an overtime fee. For shoots that need to go over this duration, the Museum can provide our conference room for the use of filming. These fees will be \$100 for the first 30 minutes and \$250 for each following 30 minutes, paid to the Museum prior to departure.

6. All filming equipment must be placed and removed within the specified time period.

7. All equipment and crew members must adhere to designated areas during the filming.
